Dear Dr. Brown,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 4, 2019 letter reporting two instances of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Alabama at Birmingham. According to the information provided, OLAW understands the following about the incidents and the corresponding corrective actions:

1) Two pigs were singly housed during acclimation and fed an experimental diet not described in the approved protocol. There was no adverse impact on the animals.

Corrective action: The investigator was counseled and the protocol was amended to include the diet and acclimation deviation.

2) Eighty five mice were given an analgesic cocktail following surgery and one of the drugs in the mixture had expired. There was no adverse impact on the animals.

Corrective action: The surgeries were stopped until in-date analgesics were obtained and the investigator was counseled on observing expiration dates of all drugs given to animals.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of these problems. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse:

Below are descriptions of unapproved deviations from the Guide for the Care and Use of Laboratory Animals and/or the PHS Policy identified and discussed during the February (2019) IACUC full committee meeting. All incidents of non-compliance were discovered through post approval monitoring and involved a single investigator. Described corrective actions for each incident are also included.

Failure to follow the IACUC approved protocol: two swine were singly housed during the acclimation period and provided a special diet containing Cyclosporine that was not included in the approved IACUC protocol. The special diet had been included in a previous version of the PI's protocol, but was not included in the current version. There were no adverse effects to the animals noted due to the deviations. This incident-involved work funded by NIH grant R01HL114120.

Expired compound administered to rodents: A routine laboratory audit conducted by the Compliance Coordinator determined that 85 mice had undergone a surgical procedure using an expired drug. Animals received a combination of Carprofen and Buprenorphine analgesic for postoperative pain management; however, the audit discovered that the Carprofen used was past its expiration date (although the other analgesic was within date and fully effective). No adverse effects were noted in the animals' health status records, and all surgical procedures were halted until the correct analgesics could be acquired. This incident-involved work funded by NIH grant R01HL114120.

Corrective actions included counseling by the Compliance Coordinator on the importance of knowing and following the approved protocol, and protocol modification for special diet and acclimation deviations. Ordering of in-date Carprofen along with counseling by the Compliance Coordinator related to careful observation of expiration dates for any compounds administered to animals was reinforced.
