Dear Ms. Diaz,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your June 27, 2018 letter reporting an adverse event impacting research mice at St. Jude Children's Research Hospital, following up on an initial report on June 20, 2018. According to the information provided, OLAW understands that one mouse died and three were moribund after their cages flooded from a cracked water pipe.

The corrective actions consisted of euthanizing the moribund mice and treating any others that were affected. The treated mice recovered, the pipe was repaired, a cut off valve was installed in the piping system, the other lines were inspected, a leak detection system will be installed, and a plan was established to replace all current polypropylene piping.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and reduce the likelihood of a recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Subject: Report of Noncompliance/Animal Welfare Assurance D16-00043

Dear Dr. Wolff:

Please accept this written report, which documents an incident of noncompliance with Public Health Service (PHS) policy governing the care and use of laboratory animals. A description of the incident and the corrective actions taken to prevent the recurrence of a similar incident of noncompliance are provided below.

In the early hours of June 2, 2018, a pipe in an interstitial floor that distributes reverse/osmosis (RO) purified water to procedure labs in the building cracked and began leaking. A significant volume of water leaked from the pipe before the damaged pipe was detected. Water seeped into an animal room below the damaged pipe. Two cages on the top shelf of a cage rack were flooded. One mouse died and three mice were found moribund and were euthanaized. The remaining mice were provided with supportive care and recovered uneventfully.

The following corrective actions have been taken to prevent recurrence of the incident.

- 1) The section of damaged pipe has been replaced and an isolation valve has been installed to cut off water to the distribution pipes.
- 2) The distribution lines have been visually inspected for evidence of degradation that might result in cracking.
- 3) Plans for a water detection system on the floor of the interstitial space is being evaluated for leak detection and prompt abatement of the risk to animals and damage to the infrastructure of the building.
- 4) In the upcoming fiscal year (July 1, 2018 June 30, 2019), Facilities Operations and Maintenance will hire a contractor to replace all polypropylene RO/DI piping in the interstitial levels.

The mice involved in this report were on a project supported by a PHS funded award to the Principal Investigator.

This incident was reported to the ACUC at the June 21, 2018 committee meeting.
