#### INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

The Institutional Animal Care and Use Committee (IACUC) did not adequately review animal activities being performed under the rabbit antibody production protocol. Review of the blood collection SOP, the polyclonal antiserum production SOP and the newly approved policy on antibody production indicates that the amount of blood collected and the weights of the rabbits will be recorded in order to monitor the health of the rabbits and ensure that the blood volume collected does not exceed approved amounts. Blood collection records did not indicate the amount of blood collected, although weights are regularly recorded.

Adequate IACUC review of animal use is necessary to ensure that activities involving animals are being conducted in accordance with the Animal Welfare Act. The IACUC should make certain that all activities relating to the care and use of animals receive adequate oversight and that the activities are in accordance with the IACUC approved protocols, SOP's and policies.

#### ENVIRONMENT ENHANCEMENT TO PROMOTE PSYCHOLOGICAL WELL-BEING.

The current Environmental Enhancement Plan (EEP) for non-human primates was approved by the previous veterinarian. A system should be in place to ensure the EEP is updated and signed by the current attending veterinarian.

The current EEP for non-human primates indicates that toys will be evaluated for "evidence of diminished integrity", complete with pictures of toys that were no longer appropriate. There were two toys present in enclosures with Macaques that showed evidence of diminished integrity. A system should be in place to ensure that the EEP is followed.




