Dear Dr. Purdy,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your December 16, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Columbia University following up on an initial August 9, 2019 notification by telephone.

According to the information provided, this Office understands that the Columbia University Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: an individual conducting mouse survival surgery not in compliance with the applicable protocol. On July 31, 2019, an IACUC post-approval monitor notified the Executive Director of the IACUC, that an individual conducting mouse survival surgery was not in compliance with the approved protocol. The letter states that the research was supported by the Public Health Service under NIH. The violations observed by the PAM monitor include:

- Poor aseptic technique.
- · Administration of two drugs not listed on the protocol.
- Failure to follow the protocol with respect to administration of postoperative analgesia.

The IACUC investigative team met with the investigator, the researcher who had conducted the surgery, the lab manager and mentor of the individual responsible for the noncompliance. A meeting was also held with the PAM monitor separately. A report from the investigative team was provided to the IACUC at the convened meeting held on October 10, 2019. The committee voted to impose the following corrective actions:

- Termination of the experiment observed by the post-approval monitor.
- Extensive online and hands-on veterinary retraining for the individual responsible.
- In person veterinary retraining for all individuals who perform surgery under the applicable protocol.
- Combination of two surgical protocols to reduce confusion and use of surgical checklist and revising of a surgical record template to facilitate compliance.

On August 9, 2019, Columbia University (the "University") notified the Office of Laboratory Animal Welfare ("OLAW") by telephone of an incident in which an individual was conducting mouse survival surgery not in compliance with the applicable protocol. The research was supported by the Public Health Service under NIH grant # 5R01 EY011787-18 and a subaward under grant # 1R01 MH115900-01A1.

This letter reports the results of a review of the incident and the corrective actions taken by the Institutional Animal Care and Use Committee ("IACUC").

## Background and Investigation

On July 31, 2019, an IACUC post-approval monitor notified Dr. Mary Jo Shepherd, Executive Director of the IACUC, that an individual was conducting mouse survival surgery out of compliance with the approved protocol. The violations observed included poor aseptic technique, administration of two drugs not listed in the protocol and failure to follow the protocol with respect to administration of postoperative analgesia.

Dr. Shepherd notified the IACUC Chair when she learned of the incident and an investigation was initiated. The IACUC investigative team (Dr. Shepherd and another IACUC member) met with the principal investigator, the researcher who had conducted the surgery in question, the laboratory manager and the mentor of the individual responsible for the noncompliance. They also met separately with the post-approval monitor who made the observations.

## **Corrective Actions**

A report from the investigative team was provided to the IACUC and a convened meeting of a quorum of the Committee was held on October 10, 2019. Following review of the facts and discussion, the Committee voted to impose the following corrective measures:

 The investigator was required to fully implement and continue to adhere to his plan for correction, which included termination of the experiment observed by the post-approval monitor; extensive online and hands-on veterinary retraining for the individual responsible; inperson veterinary retraining for all individuals who perform surgery under the applicable protocol; combination of two surgical protocols to reduce confusion; and use of a surgical checklist and revision of a surgical record template to facilitate compliance.
