Dear Dr. Manning,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your March 28, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals, following up on an initial telephone report on January 29, 2019. According to the information provided, OLAW understands that there was no documentation of the provision of analgesia to 40 mice following a craniotomy procedure. The Principal Investigator (PI) stated that the drugs had been given, that this was documented on the cage cards, but that the cards had been discarded.

The corrective actions consisted of the PI retraining the laboratory staff on documentation and records retention and requiring the laboratory's analysis logs to be submitted to the Institutional Animal Care and Use Committee (IACUC) for one year. The IACUC accepted the PI's corrective actions.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the IACUC to comply with the PHS Policy.

In accordance with PHS Policy IV.F.3.a, Vanderbilt University Medical Center (VUMC)/ Vanderbilt University (VU) or the Department of Veterans Affairs Tennessee Valley Healthcare System (TVHS) Institutional Animal Care and Use Committee (IACUC) is self-reporting an incident involving a laboratory that did not document analgesic administration as outlined in their IACUC-approved protocol. A preliminary report was filed by VUMC via phone with OLAW on January 29, 2019.

This is the final report provided to the Office of Laboratory Animal Welfare (OLAW) regarding the issue.

Species Involved: Mouse

Funding Source: Foundation, Endowment, and NIH funding. NIH Grant numbers: MH107435-01A1, MH100096 and M0044064

Incident Description:

On January 8, 2019, during the IACUC semi-annual inspection (SAI) it was found that post-operative administration of analgesia (Ketoprofen) was not documented on the analgesic log for approximately 40 mice that underwent a craniotomy procedure. The IACUC-approved protocol indicates that 72 hours of post-operative analgesia will be provided.

IACUC Actions Taken and Corrective Plans:

The information gathered by the Office of Animal Welfare Assurance (OAWA) at the SAI was brought to the IACUC at a convened meeting on January 23, 2019. The IACUC discussed the facts and voted to require that the Principal Investigator (PI) provide a plan to prevent recurrence, retrain the laboratory staff, and submit the laboratory's analgesic logs for review for one year beginning in February 2019.

Implementation of Changes: In correspondence dated January 24, 2019, the PI assured the IACUC that the analgesics had been given. The laboratory

The PI discussed the issue with laboratory personnel and provided training on appropriate methods for documenting and retention of analgesic records. The PI agreed to analgesic log review for one year.

At its convened meeting on February 27, 2019, the IACUC discussed the PI's response to the incident and found that the actions taken addressed the concerns and the PI had provided an appropriate plan to prevent reoccurrence of the issue. The IACUC considers the incident closed.

As always, Vanderbilt University Medical Center, Vanderbilt University and the Department of Veterans Affairs Tennessee Valley Healthcare System remain committed to the highest standards of compliance related to the humane use of animals in research, teaching and testing.
