Dear Dr. Feustel,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 27, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Albany Medical College, following up on an initial report on August 30, 2018. According to the information provided, OLAW understands that a live rat was found in the carcass freezer due to a failure to verify death following an unapproved attempt of cervical dislocation for euthanasia.

The immediate action taken upon discovery consisted of correctly euthanizing the rat and suspending vivarium access for the trainee responsible. The corrective actions consisted of retraining the individual, restoring vivarium access, allowing only senior Animal Resources Facility staff to euthanize rats, and transferring rats to another protocol if a training procedure is followed by unsupervised euthanasia.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

As Institutional Official of Albany Medical College (AMC), I am submitting this follow up report to a previously reported incident on August 30, 2018.

Explanation for Incident (previously reported): On August 28th, a live rat was discovered in the necropsy freezer after a non-IACUC- compliant euthanasia procedure which was unsuccessful.

Corrective Actions (previously reported): The individual responsible was identified and Animal Resources Facility (ARF) access immediately (on August 28th) suspended by the ARF director. The IACUC needs to meet to consider further action.

Corrective Actions (NEW): The individual involved attended the IACUC meeting on the 20th of Sept. She had sought training from an ARF staff member on tail vein catheterization. At the completion of the catheterization training the instructor asked the trainee to euthanize the rat. The instructor assumed that the trainee had experience in performing this procedure and the trainee assumed that, having performed the cervical dislocation procedure many times in mice, she could do it successfully. She attempted the procedure and placed the presumed dead rat in the freezer. The rat was found alive 20-30 minutes later by the ARF staff member and immediately properly euthanized. The IACUC concluded that the trainee should have not undertaken the euthanasia and the instructor should have verified that rat euthanasia training had been previously performed.

The trainee and the protocol PI attended the IACUC meeting of 20 Sept. Based on that interview and the lack of any prior instance of non-compliance with either individual, the IACUC was convinced that this mistake was unlikely to be repeated. The IACUC directed that, after completing training, that access to the facility be restored. The IACUC also requested that a corrective action plan be submitted to the IACUC. The PI agreed and responded in writing on Sept 26th. From the PI: "... To ensure that such an incident does reoccur under my protocol, I have undertaken the following measures. No rat listed under my training protocol will be passed to the custody of anyone outside of senior ARF staff for euthanasia. If an animal user wishes to practice a technique on a rat that results in euthanasia without

veterinary technical supervision, the rat will first have to be transferred onto another approved protocol via the amendment process. ..." The response was circulated to the committee and approved on September 27th.

The Albany Medical College is committed to assuring the welfare of all animals used in research. This report provides and describes the circumstances and actions taken. If you have any questions, please do not hesitate to contact me.
