Dear Dr. Taubman,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 20, 2017 letter reporting a noncompliance with the PHS Policy on the Humane Care and Use of Laboratory Animals at the University of Rochester Medical Center. According to the information provided it is understood that on April 19, 2017 the University Committee on Animal Resources voted to temporarily restrict a lab staff member's animal access and lab work. This action was prompted by repeat non-compliance by the staff member and failure of the investigator's previous corrective action plan. It was not stated if the animal(s) involved was (were) assigned to an activity that received PHS or NSF funding.

The PI and staff member met with the UCAR Chair and the Attending Veterinarian. The investigator has undergone retraining and will be on probation for the next three months.

OLAW believes that the corrective measure put in place by the University of Rochester Medical Center is consistent with the provisions of the PHS Policy on Humane Care and Use of Laboratory Animals. In all future reports please include the species of animal, approximate number of animals involved, a description of the actual noncompliant activity, and whether or not the project was funded by the PHS or NSF. We appreciate being informed of this matter and find no cause for further action by this office.

Report of Noncompliance

During the April 19, 2017, meeting, the University Committee on Animal Resources discussed an issue of a lab staff member who has accumulated several occurrences of non-compliance since his recent approval to work with animals.

This staff member has recently had issues with animal transport and post-op procedures. The investigator had previously put forth an action plan but recurrences happened. UCAR had notified both the investigator and the staffer that any additional occurrence will result in restricting animal access. There was an additional occurrence, prompting action to be taken by the committee:

The committee voted to suspend this staff member's animal access and lab work until a meeting can be scheduled between the PI, staff member, UCAR chair and attending veterinarian; The investigator will have to undergo retraining with our Compliance officer to help the investigator understand what the university's expectations are regarding the use of animals in research will only perform only perform surgical procedures when supervised by one of the university's veterinarians or a Vet. Tech.; The investigator will remain on probation until the completion of their experiments over the next 3 months, during which time any further incidence of noncompliance can result in the permanent suspension of their animal use privileges at the university. The investigator has agreed to cooperate with UCAR and the Animal Resource Office to ensure complete compliance in the future.

Post Suspension Note: Since the suspension, the investigator and their PI have met with attending veterinarian and UCAR chair and has completed the necessary retraining as required by the UCAR. Furthermore, the investigator understands that he is on probation for the remaining set of experiments over the next 3 months and that any further noncompliance can result in the loss of their ability to work with animals at the university. The investigators access to animals and their ability to work with them has been reinstated on a probationary status.
