Dear Dr. Giannelis,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 6, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Cornell University. According to the information provided, OLAW understands that on November 21, 2018 two mice on a water deprivation study were found to be dehydrated. The mice were examined, provided water and recovered fully. There was no written record of anyone from the PI's lab checking on the animals or providing water from 11/19/2018 to 11/21/2018. The student responsible for the incident failed to notify the lab technician that she was initiating a water deprivation study, so no autoreminders for animal checks were initiated in the lab messaging system. A similar occurrence had taken place earlier in the month with the same mice. The affected animals were on an activity that was funded by the PHS.

Corrective actions included veterinarians counseling the PI and the lab group. The lab now has a policy that no one may initiate a water deprivation experiment without first obtaining permission from the lab technician and the PI. The student responsible for the incident no longer works with this lab.

The prompt consideration of this matter by Cornell University was consistent with the philosophy of institutional self-regulation. Similarly, the actions taken to resolve the issue and prevent recurrence were appropriate. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Wolff:

As Institutional Official for Cornell University's animal care and use program, I am reporting an incident of noncompliance that occurred under our General Assurance. This incident involved two mice and occurred on November 21, 2018. This issue was reported to the IACUC at the December 13, 2018 meeting, and the IACUC agreed that the corrective actions taken were appropriate.

Explanation of the situation:

On November 21, 2018, two mice that were on a water deprivation study were found by the facility manager to be dehydrated. Veterinary staff from the Cornell Center for Animal Resources and Education (CARE) examined the animals and found both mice dehydrated, hunched and with decreased body condition. There was no written record of anyone from the Principal Investigator's (PI's) lab checking on the animals or providing water from 11/19/2018 to 11/21/2018. A similar occurrence had taken place earlier in the month with these same mice.

The mice were provided with water immediately and recovered fully. The PI and lab responded quickly and found that the rotating student in charge of the mice had failed to update records and/or had not given the mice water when they were supposed to. This rotating student subsequently was not offered a position in the lab, and was asked to find a new lab to work in.

Action taken by the institution:

Although the PI is confident that similar issues will not reoccur since the offending student is no longer present, veterinarians from the Cornell Center for Animal Resources and Education met with the PI and the lab group to better understand lab practices and review record-keeping procedures in an effort to prevent these sorts of issues from recurring. Even though there is a lab messaging system in place that sends autoreminders for animal checks, in this case the student did not let the technician know that she was initiating a water deprivation study, so the messaging system was not activated. The lab has a new policy that no one may initiate water deprivation experiments without first obtaining permission from the lab technician and the PI.
