Dear Dr. Taraschi,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 22, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Thomas Jefferson University, following up on an initial telephone report on May 24, 2018. According to the information provided, OLAW understands that recently expired anesthetic had been used on numerous mice. The laboratory had made aliquots of the drugs but did not include the expiration date.

The corrective actions consisted of removing the drugs and marking them as expired. The laboratory staff was counseled, provided a copy of the institutional drug use policy, and will now label all aliquots with expiration dates. All animal users were reminded not to use expired anesthetics or analgesics, an online training module on controlled drugs must be taken by all investigators using these agents, and the matter was discussed in the Institutional Animal Care and Use Committee newsletter.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct, and prevent recurrence of the noncompliance. We appreciate having been informed about this matter and find no cause for further action by this Office.


