Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your July 26, 2018 letter reporting a noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. According to the information provided, OLAW understands that 26 out of 40 cowbirds housed in an outdoor flight cage at your New Boulton Center site were found dead. The water bowls were empty and it appeared the cause of death was dehydration. The remaining birds were relocated and survived. Apparently the incident was related to unusually hot weather and the birds using the water bowls as water baths. They splashed the water out of the bowls. The animals were assigned to work funded by NSF grant 1557499.

Corrective and preventive actions included keeping the flight cage closed until the fall. The number of birds in the cage will be limited to 30 and additional water stations will be added. Water bowls will be replaced by water trays to increase volume and allow the birds to bathe without great water loss. The cage will be moved from concrete to grass to keep the area cooler and more shade panels will be added to the cage. The cage will be checked more frequently.

The prompt consideration of this matter by the University of Pennsylvania and the PI was consistent with the philosophy of institutional self-regulation. Similarly, the actions taken to resolve the issue and to prevent recurrence were appropriate. We appreciate being informed of this matter and find no cause for further action by this office at this time.

Dear Dr. Wolff,

We wish to report an incident with cowbirds (*Molothrus eter*) housed in an outdoor flight cage (8' long x 4' wide x 8' high) at our New Bolton Center site. The work was funded by a NSF grant 1557499. During a daily check, 26 birds out of 40 were found dead. The health of the surviving birds was immediately addressed and a ULAR veterinarian was contacted. The water bowls were empty and it appeared the cause of death was due to dehydration. All the remaining 14 birds all survived and were relocated. The flight cage was taken out of service during the investigation of the incident.

The PI self-reported the issue to the IACUC Chair and Office of Animal Welfare compliance staff. An investigation by the PI and the veterinarian concluded that there was adequate drinking water provided in water bowls the day before. However, since it was an unusually hot day, the birds used the water bowls as water baths and splashed out the water. The birds quickly became dehydrated. The investigation had a number of recommendations, many of which were PI-suggested preventative measures:

- The number of birds in the cage will be limited to 30;
- The water bowls will replaced by water trays which has an increased volume and makes it easier for bird bathing behavior without great water loss;
- Additional water station locations will be added;
- Move the cage over grass instead of concrete to keep the area cooler;
- Add more shade panels to the cage;
- Increase frequency of checks on the cage.

Additionally, the PI will keep the flight cage closed for the summer but may consider using it in the fall.

The recommendations were accepted by the PI and the IACUC compliance subcommittee. The IACUC was updated at the next regularly scheduled IACUC meeting.
