Dear Dr. Bonnell,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 13, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Pennsylvania. According to the information provided, OLAW understands that one mouse was subjected to a tail snip for genotyping without anesthesia, more tissue was taken than outlined in institutional guidelines, and one individual was not listed on the protocol.

The immediate action taken upon discovery consisted of providing analgesics for the mouse. The corrective actions consisted of stopping additional tissue collection/genotyping, counseling the Principal Investigator and laboratory staff, and amending the protocol to include the individual.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Wolff,

We wish to report an incident involving a procedure performed on a single mouse which was not approved in the IACUC protocol. Furthermore, the "off protocol" procedure was not performed in manner consistent with our IACUC guidelines for this procedure and one of the researchers involved in the study was not listed on the protocol.

The specifics of the incident were when the laboratory members attended a seminar on mouse genetic typing and then decided to take advantage of a free genotyping offer. The researchers collected a tail tissue sample from a single mouse. The amount of material collected was larger than the Penn IACUC Guidelines on *Mouse and Rat Genotyping Methods* and the mouse was not anesthetized as required by the Guidelines. Assisting in the study was a researcher that was not listed on the protocol. However, this researcher had completed all the required IACUC training. The mouse was noticed later that day by the animal care staff and a veterinary service staff member provided the proper medical analgesics. A clinical veterinarian contacted the laboratory and the IACUC Compliance team about a potential non-compliance related to the sample collection. The laboratory stopped any further sampling. The IACUC Compliance staff member investigated the incident and notified the IACUC Compliance Committee.

The IACUC compliance liaison member investigated and noted the aforementioned non-compliance items. The PI was informed on the compliance gaps and was very responsive to address the gaps. The PI and laboratory manager immediately addressed the issues with the laboratory staff. The protocol was amended to include the new researcher and the laboratory decided that genotyping is not needed for this study. The IACUC Chairperson, an IACUC Compliance Liaison person and the Assistant director the IACUC Administration met with entire laboratory and reviewed the importance of animal welfare, and the importance of staff knowing the content of their IACUC protocols and keeping them up-to-date. The IACUC Compliance
