ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

Four cats displayed abnormal signs or symptoms. "Arthur" (ID#7417) had black debris in both ears. We could not determine if this debris was causing him discomfort. "Sophie" (ID#5819) had a thin haircoat on her sides, back, and flanks. The underlying skin appeared healthy. "Sophie" has not been in any flea or tick study for at least the past year. "Cry Baby" (ID#7267) had a mucoid discharge in both eyes. The eyes were otherwise clear, with no indication of pain or discomfort. "Sam" (ID#5934) had black debris in both ears, although there was no indication of discomfort.

There was no indication from paperwork or questioning employees that the facility had noted any of these symptoms. None of these conditions were clearly impacting the animals. However, the presence of any abnormal signs should be noted by the facility staff, and appropriate followup completed.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

There is an accumulation of fencing, construction material, and other items located immediately adjacent to an outdoor enclosure containing dogs. Weeds have grown through this material, all of which is being kept directly on the ground. This is a potential source of harborage for pests and insects, and is located close enough to the dogs to impact their well being. This material must be removed immediately. It should be properly stored at an appropriate distance from regulated animals.
