Dear Dr. Gopee:

The University of Oklahoma Health Sciences Center (OUHSC), in accordance with Assurance D16-00104 and PHS Policy IV.F.3., provides this final report of an incident that my designee reported to you on May 22, 2018, involving a non-PHS funded project. The University's final report is as follows:

On April 24, 2018, animal care staff observed a research associate not following the IACUC's approved practices while euthanizing mice with carbon dioxide. The animal care staff made the research associate aware of the procedural deviations and immediately assured all other animals were euthanized in accordance with the IACUC's approved practice. The animal care staff then promptly reported the incident to a program veterinarian. The veterinarian exercised veterinary authority and issued a directive that the PI's research associates would no longer perform euthanasia on animals. The veterinarian advised the IACUC of this issue shortly thereafter.

On May 2, 2018, after consulting with members of the IACUC, the PI elected to voluntarily cease all IACUC approved animal use activities, effective immediately. The PI then proposed a remediation plan to the IACUC. During its general Committee meeting on May 9, 2018, the IACUC reviewed a summary of the events and the following remediation plan proposed by the PI:

- During the duration that all IACUC approved animal use activities are ceased, the PI and research associates will review approved animal activities and implement mandatory training on the University's animal care and use program policies.
- The PI will ensure the on-going care of his research animals while the laboratory has ceased all IACUC approved animal use activities.
- A research associate in the PI's laboratory was assigned to help manage the PI's animal
 activities. The associate will participate in the Animal Research Coordinator (ARC)
 certification program offered by the University's Office of Animal Welfare Assurance
