Dear Dr. Alivisatos,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your February 2, 2017 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of California- Berkeley, following up on an initial telephone report on April 7, 2016. According to the information provided, OLAW understands that several guinea pigs were given a lower dose of anesthetic than described in the approved protocol, record keeping for controlled drugs was inadequate, and expired analgesics and euthanasia drugs were used.

The corrective actions consisted of stopping the imaging procedure for which the anesthetics were used, retraining the Principal Investigator (PI) and staff on appropriate handling of controlled drugs and on maintaining animal health and research records, using color codes on drugs and checking inventory monthly, and counseling the PI and staff on record keeping and following the protocol. The PI was directed by the Animal Care and Use Committee to improve management of the laboratory and the laboratory was placed under enhanced oversight by the veterinarians and the Office of Animal Care and Use. The protocol was amended to include the lower dose of anesthetic and the animal activity resumed.

Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate, correct, and prevent recurrence of the noncompliance. We appreciate having been informed about this matter and find no cause for further action by this Office.

RE: Animal Welfare Assurance #A3084-01

This is to follow up on the preliminary report that you received via a phone call on April 7, 2016 from Secondary Individual Director of the Office for Animal Care and Use (OACU). The call was made on behalf of the Animal Care and Use Committee (ACUC) and pertained to an animal welfare incident involving guinea pigs. The incident was discovered during a routine USDA visit (inspection).

The incident encompassed several issues:

- Use of lower doses of an anesthetic agent combination (ketamine and xylazine) to reduce animal recovery time for a non invasive imaging procedure than what was approved in the protocol. Although researchers consulted with OLAC veterinarians who indicated the lower anesthetic dose was appropriate for the procedure the PI neglected to submit an amendment to revise her protocol.
- Continued use of the unapproved dose of the anesthetic agent combination between 3/24/2016 and 4/5/2016 for 11 guinea pigs by lab personnel despite the PI's statement that such activity had ceased.
- Inadequate record keeping for the controlled drug, specifically inadequate documentation of use per animal and expired controlled substances were not separated from unexpired controlled drugs.
- Sedative/analgesic (xylazine) and euthanasia agents used beyond their expiration date.

Subsequent investigation by the ACUC determined that collectively, these issues comprised a serious noncompliance with PHS Policy on the Humane Care and Use of Laboratory Animals. Based on the ACUC investigation, the following steps have been taken to address this incident:

- 1. The PI voluntarily ceased the specific imaging procedure that required use of the anesesthetic agents in question.
- 2. The PI and her lab personnel underwent retraining by the EH&S Controlled Substances Used in Research program Leader. This retraining covered use, record keeping, storage and disposal of expired controlled drugs.

- 3. The PI implemented an SOP that employs a color-coded system to track drug inventory. As part of this SOP, a senior staff member is responsible for verifying inventory each month.
- 4. An OLAC veterinarian worked with the PI and lab personnel to ensure that health and research records for each guinea pig are appropriate and accurately record all drug doseages and procedures performed on each animal.
- 5. The AV met with the PI and her lab to reinforce the importance of appropriate record keeping and the need to follow the ACUC-approved protocol, meaning that changes to drug doseages and/or procedures cannot be made without appropriate review and approval by ACUC.
- 6. OLAC veterinarians and OACU staff have made multiple follow-up visits to the PI's lab to ensure that all of the above corrective measures have been and are continuing to be implemented as directed.
- 7. The PI attended an ACUC meeting to discuss direct methods for improving the management of her lab so as to ensure that these issues do not reoccur in the future.
- 8. As requested by ACUC, OACU staff continue to monitor this lab closely by performing announced and unannounced post-approval monitoring visits.

The ACUC approved the corrective actions outlined above and plans to continue to monitor this PI's activities closely. A protocol amendment containing a lower dose of the anesthetic agent combination was subsequently submitted to and approved by the ACUC. The PI then re-initiated the imaging procedure that necessitated anesthesia.

The PI has informed the ACUC that the activities were performed under NIH/NEI EY12392 funding.

As Institutional Official, I am satisfied that the campus has spared no resources in resolving this unfortunate incident and thereby has fulfilled its commitment to maintaining the highest standards of animal welfare, as described in our Animal Welfare Assurance.
