Dear Dr. Alivisatos,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 18, 2016 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of California- Berkeley, following up on an initial report on May 20, 2016. According to the information provided, OLAW understands that twelve rats failed to receive post-surgical analgesia as described in the approved protocol, one rat died, and one required additional care. There were no analgesics present in the laboratory and non were on order.

The corrective actions consisted of retraining the laboratory staff on anesthesia/analgesia, ordering the appropriate drugs, and having the Principal Investigator assure the Institutional Animal Care and Use Committee (IACUC) that the protocol will be followed.

OLAW understands that the protocol involved was not PHS-supported, but concurs that the incident was serious and supports the actions taken by the IACUC. The establishment and application of policies and practices that are consistent with the provisions of the PHS Policy at the University of California- Berkeley are commendable and avoid the perception of a double standard. Thank you for keeping OLAW apprised on this matter.

Hello Dr. Wolff:

This is a preliminary notification of an animal welfare & protocol noncompliance issue with twelve rats. Eight rats underwent one surgical procedure and another four rats underwent a different surgical procedure; however in neither procedure did the lab personnel follow the approved protocol and provide analgesia as described. One of the eight in the first procedure died and a second animal needed additional post-op care but has recovered. One of the OLAC Veterinarians and the OLAC Trainer have already provided re-training to the lab. The PI has been contacted to determine the funding support of these animals. A final report from the IO will be forthcoming when ACUC is done with its investigation.
