Dear Dr. Wolff,

I am writing to provide OLAW with information that was not included with our adverse incident report dated June 26, 2017 that resulted in the fatalities of laboratory mice. If you may recall, the incident that the University of Hawaii (UH) reported was the result of an unapproved behavioral procedure that was conducted between January/February-August 2015. The IACUC only recently became aware of the activities while investigating a reported animal welfare concern complaint.

In OLAW's response to UH dated July 6, 2017, Dr. Jane Na, OLAW VMO, reminded us for future reports to specify whether the associated animal work was supported by PHS, NSF, or VA funding, and to include the relevant grant or contract numbers.

For this animal work, the animal use protocol was supported by PHS funding through NIH grant COBRE-IBR (P20 GM103457) Project 2: The Impact of Assisted Reproductive Technologies on the Long-term Epigenetic Regulation of Neurodevelopmental Genes Associated with Autism.

No animals are currently being housed or being used for the study. The animal use protocol "Role of Neuroepigenetics in Sociobehavioral Defects of Autism" expired in October 2016; therefore, is not active.
