Dear Dr. Erzurum,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 27, 2018 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Cleveland Clinic. According to the information provided, OLAW understands that two mouse cages were kept in a room that had not been approved for animal housing on the protocol.

The corrective action consisted of the Principal Investigator counseling the laboratory staff regarding the content of the approved protocols and labeling all rooms in the laboratory as to whether or not they are approved for animal activities.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Dear Dr. Morse;

The Cleveland Clinic Institutional Animal Care and Use Committee (IACUC) concluded that animal research non-compliance occurred in the Cleveland Clinic Animal Care Program. The incident occurred when two mouse cages were placed in a room outside of the animal facility that was not approved for animal research. This room had previously been approved for animal research, but its use was not included on the protocol involved. In response to this incident, the PI has met with his research laboratory to ensure that they understood the protocols on which they are working, and has made a series of administrative changes to minimize potential confusion including labeling all rooms in the laboratory area with respect to whether or not they are approved for animal research.

The IACUC reviewed this incident at the November 15, 2018 meeting and determined that this was reportable research non-compliance, but felt that no further action beyond that already taken by the PI was needed.

The Animal Welfare Assurance number for Cleveland Clinic PHS-funded grants is A3047-01. This protocol was funded internally.
