This letter reports a new incident of non-compliance with PHS Policy and the Guide for the Care and Use of Laboratory Animals at the Indiana University School of Medicine for one of our IACUC protocols covering laboratory mice.


An issue of possible animal welfare was discussed at a SOM IACUC full board committee meeting. Please find a summary of the reported incident below.

The committee discussed a report about 19 rats which were found without food and 14 rats which were found without water inside a LARC housing room. The PI's lab staff are responsible for all husbandry care for the animals in the room. No animals died as a result of the food and water deprivation. To ensure this would not occur in the future, the PI held an emergency lab meeting to address these concerns. The PI stated that the lab has planned additional measures, including double-checking all animals, to ensure that this would not occur again.

After significant time in deliberation and based on their understanding of the facts presented, federal regulations, and expectations, the IACUC committee members determined that this issue qualifies as an animal welfare concern.
