Dear Dr. Brown,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 1, 2019 letter reporting a serious deviation from the provisions of the *Guide for the Care and Use of Laboratory Animals* at the University of California San Diego, following up on an initial telephone report on March 18, 2019. According to the information provided, OLAW understands that 30 mice died or required euthanasia after not receiving water due to a malfunctioning rack hose coil.

The corrective actions consisted of replacing the hose, changing rack flush and water flow checks to daily instead of weekly, and retraining the husbandry staff on recognizing dehydration in mice.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals.

Per PHS Policy IV.F.3, I am writing to advise you of an incident that occurred in a UC San Diego vivarium. On February 11, 2019, a Principal Investigator's lab staff contacted the Animal Care Program (ACP) oncall staff after hours and reported that research mice on one ventilated rack were lethargic or dead, and it appeared to be from dehydration. The ACP staff responded quickly and found the hose coil on that rack was malfunctioning, resulting in a failure of the rack watering system. The hose coil was immediately replaced. The rack's flushing mechanism and water flow had been checked on February 8, 2019, and were working properly. All animals were checked daily with no reports of dehydration, however, 30 mice were subsequently found dead or euthanized due to apparent dehydration.

Prior to this incident, water flow checks on the racks were performed using a combination of random spot checks (not required daily), daily system pressure and flow data monitoring with alarms, water flow checks on all newly placed cages on existing racks, and water flow checks on all newly placed racks and associated cages. To help prevent further occurrences, ACP husbandry management modified the rack flush checks to daily instead of weekly, water flow checks are now conducted daily (including weekends), and Animal Care staff were retrained in identifying dehydration in mice. The vendor's inspection report of the old hose coil is still pending. Per the Principal Investigator, no NIH funding supported the animals that were affected by this incident.


