The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your August 10, 2018 letter reporting two instances of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Cincinnati, following up on an initial telephone report on the same date. According to the information provided, OLAW understands that in two different studies, post-operative analgesics were not given to mice as had been described in the protocol. In the second situation, there were also no surgical records present on the cages.

In the first case, the corrective actions consisted of amending the protocol to justify withholding of analgesics and having the Institutional Official (IO) sending a letter of counsel to the Principal Investigator (PI) stressing protocol compliance. In the second case, the PI and staff were retrained, and a letter of counsel was sent by the IO to the PI stressing protocol compliance.

Based on its assessment of these explanations, OLAW understands that measures have been implemented to correct and prevent recurrence of these problems. OLAW concurs with the actions taken by the institution to comply with the PHS Policy and notes that the Institutional Animal Care and Use Committee is to place a high burden of proof on the PI regarding the scientific justification for withholding analgesics and to consider possible palliative measures. Thank you for informing OLAW about these matters.

In accordance with PHS Policy and the terms of our Assurance Statement, we are advising you of two issues of non-compliance discussed at the July 12, 2018 meeting of the University of Cincinnati Institutional Animal Care and Use Committee (IACUC).

1) Post-surgical analgesics were not administered to mice as described in the approved protocol.

Corrective Actions:

- During a PAM audit it was determined that a laboratory had not followed the approved analgesic regimen. Researchers explained that analgesics interfered with the immune response and was therefore being administered on an as-needed basis.
- The PI was advised to amend the protocol to scientifically justify withholding analgesics. The protocol amendment has been submitted and approved by the IACUC.
- A letter was sent from the IO to PI outlining the corrective actions for remediation with a reminder of the importance of observing protocol compliance and maintaining all aspects of animal welfare.

2) Surgical records and post-surgical analgesics were not administered to mice as described in the approved protocol.

Corrective Actions:

- During a PAM audit it was observed that no surgical records were present on two cages of mice that still had sutures in place. The lab indicated that it was an inadvertent oversight. Upon review it was determined that the lab had also not provided analgesics as described in the protocol
- The IACUC mandated that the IACUC Office and veterinary staff provide retraining to review the protocol specifics with the PI and lab research staff.
- A letter was sent from the IO to PI outlining the corrective actions for remediation with a reminder of the importance of observing protocol compliance and maintaining all aspects of animal welfare.
