This report summarizes the IACUC's results of its most recent program review and facility inspection, as required by the Public Health Service (PHS) Policy on Humane Care and Use of Laboratory Animals (<u>Policy</u>), Section <u>IV.B.1.-3.</u>, the *Guide for the Care and Use of Laboratory Animals* (<u>Guide</u>), and the Animal Welfare Act (<u>AWA</u>) regulations, as applicable.  - Four investigators are approved for the use of non-pharmaceutical grade compounds. In three situations, no USP/FDA approved equivalent was available and in one situation the compounds were part of an ongoing study. The IACUC reviewed the modifications and protocols and found the exceptions to be justified.

2) The use of thoracic compression as a method of euthanasia was approved for wild birds in the field for two researchers. Thoracic compression was removed from the list of acceptable methods of euthanasia partially because it can cause distress to the animal if not performed correctly. The researchers have over 30 years of experience in the field with this method and the IACUC was confident that there would be no additional distress to these animals.

The IACUC addressed an issue wherein a group-housed mouse died over a weekend and the staff member observing the animals over the weekend failed to notice the death. The IACUC met the same week. The IACUC required all staff be retrained on the necessity of observing each animal and required them to sign a statement verifying the retraining. The staff was retrained within two days after the IACUC meeting.
