Dear Dr. Schmidt,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 2, 2017 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Northeast Ohio Medical University (NEOMED). Your letter supplemented the information contained in an initial telephone report to this office on August 24, 2017. According to the information provided, OLAW understands that outdated Nembutal was used to anesthetize mice as part of a terminal procedure. There was no signs of pain or distress with the animals. The involved animal activity was funded by the NIGMS grant # 5R01GM112044-03.

Corrective actions proposed by the PI and accepted by the IACUC included: 1) only small aliquots of anesthetic will be obtained by the lab; 2) the expiration date will be checked and recorded before each experiment, and; 3) a reminder will be placed on the lab electronic calendar with a reminder two weeks before the expiration date. Also, the PI and research staff completed additional training in controlled substances and in rodent anesthesia/euthanasia. It is also understood that costs related to this incident were not charged to the grant.

OLAW appreciates the prompt consideration of this matter by NEOMED, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate and correct the deficiency, and to prevent recurrence. We appreciate being informed of this matter and find no cause for further action by this office.

Dear Dr. Wolfe:

The Northeast Ohio Medical University (NEOMED), in accordance with Assurance #A-3747-01 and PHS Policy IV.F.3., provides this final report of a non-compliant event. PHS-related funds were involved in this incident.

A quorum of the NEOMED Institutional Animal Care and Use Committee (IACUC) reviewed a report of non-compliance involving the use of outdated Nembutal to anesthetize mice as part of a terminal procedure. The investigator reported when the Nembutal was administered to the mice, the animals did not show signs of pain and/or distress or experience anything unusual.

In response to the event, the IACUC sent a letter to the PI requesting development of an action plan to minimize the likelihood of recurrence and to formally submit the plan in writing to the IACUC. The PI provided a written action plan to the IACUC. The IACUC reviewed the plan as part of an overall review of the matter at a regular convened IACUC meeting

The Committee acknowledged the PI's letter to the IACUC outlining the incident and unanimously agreed to accept the following revised action plan:

**Action Plan:** To prevent such incidents from occurring in the future, the PI implemented the following measures:

- 1) Small aliquots of anesthesia will be acquired from the Comparative Medicine Unit.
- 2) The expiration date of the anesthetic will be checked and recorded prior to each experiment.
- 3) A reminder will be placed in the lab's electronic calendar with a 2-week advance notice of the drug's expiration date.

**Retraining:** The PI and his research staff completed additional training in controlled substances and in rodent anesthesia/euthanasia. This training was conducted by the Attending Veterinarian. Documentation of this training is on file with the IACUC records.

The IACUC communicated to the PI, in writing, their acceptance of the above action plan.

The National Institutes of Health was notified of the event on September 29, 2017. The animal housing and related costs to this incident (\$10.40) was credited to the grant involved and was charged to an internal NEOMED account (non-federal source).

Recently the Northeast Ohio Medical University (NEOMED) experienced an animal use non-compliant event involving NIH-NIGMS funds. Outdated Nembutal was used to anesthetize mice as part of a

terminal procedure. Appropriate notification of the event is being provided to the Office of Laboratory Animal Welfare (OLAW).

The animal use protocol under which the animal was used is supported by NIH-NIGMS Award #5R01GM112044-03. The costs associated with this activity that were charged to the award (\$10.40) have been credited to the grant and were subsequently covered by a non-federal source.
