Dear Dr. Schmidt,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your January 10, 2017 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the Northeast Ohio Medical University (NEOMED). Your letter supplemented the information contained in an initial email report by condary individe to this office on September 29, 2016. According to the information provided, OLAW understands that on August 4, 2016 the desiccated carcass of a female big brown bat (*Eptesicus fuscus*) was found during the monthly change out of a flight cage by a research technician. The involved animal activity was funded by the NSF grant # NSF-CMMI 1537745.

Corrective actions proposed by the PI and approved by the IACUC included: 1) a requirement that two individuals inspect the cage and nest box at each monthly cage transfer 2) both individuals will sign-off on the Cage Change Protocol sheet once the transfer is complete, and 3) animals will be implanted with microchips and each animal will be scanned as they are transferred. In addition, the PI and research technician completed additional training in bat handling. It is also understood that costs related to this incident were not charged to the grant.

OLAW appreciates the prompt consideration of this matter by NEOMED, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate and correct the deficiency, and to prevent recurrence. We appreciate being informed of this matter and find no cause for further action by this office.

The Northeast Ohio Medical University (NEOMED), in accordance with Assurance #A-3747-01 and PHS Policy IV.F.3., provides this final report of a non-compliant event. PHS-related funds were involved in this incident.

A quorum of the NEOMED Institutional Animal Care and Use Committee (IACUC) met on August 16, 2016 to review a report of non-compliance involving the death of one female, big brown bat (*Eptesicus fuscus*). The IACUC learned that on August 4, 2016, a research technician reported finding a desiccated female bat below a clean flight cage when conducting the monthly cage change.

In response to the event, the IACUC sent a letter to the PI dated September 6, 2016 requesting development of an action plan to minimize the likelihood of recurrence and to formally submit the plan in writing to the IACUC. The PI provided a written action plan to the IACUC. The IACUC reviewed the plan as part of an overall review of the matter at a regular IACUC meeting on October 11, 2016. The Committee acknowledged the PI's letter to the IACUC outlining the incident, and unanimously requested additional information and changes to the submitted action plan. The IACUC approved the review and approval of the revised action plan via Designated Member Review (DMR).

The PI provided a revised action plan to the IACUC dated October 17, 2016. An IACUC sub-committee reviewed and approved the revised action plan via DMR. The IACUC was notified as part of another overall review of the matter at a regular IACUC meeting on November 8, 2016. The Committee acknowledged the PI's letter to the IACUC outlining the incident and unanimously agreed to accept the following revised action plan:

Action Plan: To prevent such incidents from occurring in the future, the PI implemented the following measures:

January 10, 2017 Page – 2

- 1) Two individuals are now required to inspect the flight cage and the nest box at the end of each monthly cage transfer. Both individuals will use a red light to illuminate the inside of the opaque nest box.
- 2) The investigator developed a *Eptesicus* Cage Change Protocol sheet. Both individuals conducting the change cage will sign off on this sheet once the transfer of animals is complete.
- 3) To further facilitate identification of the bats, animals will be injected with microchips. Animals will be scanned as they are transferred to a clean cage and their identification number checked.

Retraining: The PI and the research technician completed additional training in bat handling procedures on September 13, 2016. Documentation of this training is on file with the IACUC records.

The IACUC communicated to the PI, in writing on November 18, 2016, their acceptance of the above action plan.

The National Science Foundation was notified of the event on January 5, 2017. The animal housing costs related to this incident (\$3.30) was credited to the grant involved and was charged to an internal NEOMED account (non-federal source).
