The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your letter dated September 23, 2019 regarding a reportable incident at your institution. This is a final report that was preceded by a preliminary report to this office on May 28, 2019.

According to the information provided, our office understands that on January 22, 2019 a dead mouse was found on top of an incorrectly placed food hopper. This animal was part of a PHS funded project.

Corrective measures included training of lab members by animal care technicians, Training was also provided on the proper set up of rodent cages, and a post approval monitoring visit is to be scheduled.

The Institutional Animal Care and Use Committee reviewed the corrective measures and considers them appropriate.

Based on its assessment of this explanation, OLAW understands that measures have been taken to prevent recurrence of this problem. Please be advised that OLAW recommends prompt preliminary reporting of noncompliance issues with submission of a final report once corrective action has been taken. OLAW concurs with the actions taken by your institution to comply with the PHS Policy on Humane Care and Use of Laboratory Animals. We appreciate having been informed of this matter and find no cause for further action by this office at this time.

The Emory University Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the results of an event as required by section IV, F, 3a of the *Public Health Service Policy on Humane Care and Use of Laboratory Animals* (PHS Policy). A preliminary report was provided via email to Axel Wolfe on May 28, 2019. This is the final report regarding a lab had an incorrectly placed food hopper in an auto-water cage resulting in the death of a mouse. The associated NIH-funded grant is 1 R0151538-01A1.

## Situation and Assessment

On January 22, 2019 a dead mouse was found on top of an incorrectly placed food hopper on an autowater cage changed by a lab personnel in (b) (6) ab.

#### The corrective actions to prevent recurrences are detailed as follows:

- 1. DAR animal care technicians assisted with coaching the lab personnel on how to place food hoppers correctly in auto-water cages on January 22, 2019.
- All lab personnel had retraining on how to properly set up rodent cages with DAR trainers on 5-8-2019.
- 3. A PAM will be scheduled with the lab within the next month.

The IACUC believes its investigation of this incident was thorough and the corrective actions appropriate to prevent a similar occurrence. If you have questions regarding this incident, please contact me or Dr. David Martin, Director, IACUC Office.
