Dear Dr. Sherer,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 13, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Emory University, following up on an initial telephone report on June 20, 2019. According to the information provided, OLAW understands that the same kidney biopsy needle was used in succession on two separate nonhuman primates to obtain tissue samples. The sterile needle had been cleaned with alcohol between the animals but had not be re-sterilized.

The corrective actions consisted of counseling the investigator responsible on using aseptic technique. All laboratory staff working with primates was retrained on using aseptic technique and on the relevant standard operating procedures.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

#### Dear Dr. Morse,

The Emory University Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the results of an event as required by section IV, F, 3a of the *Public Health Service Policy on Humane Care and Use of Laboratory Animals* (PHS Policy). A preliminary report was provided via email to your office on June 20, 2019. This is the final report regarding the use the same sterile needle on two separate animals. The associated NIH-funded grant is NIH U01 A1132904-01.

### Situation and Assessment

On May 3, 2019, an incident occurred where a member of a research laboratory used the same sterile kidney biopsy needle to perform a kidney biopsy on two separate animals. The needle was cleaned with alcohol in between uses but was not properly re-sterilized.

The corrective actions to prevent recurrences are detailed as follows:

- 1. The PI coached the researcher involved on the importance of aseptic techniques.
- The PI had the research group that work on NHPs undergo remedial training on aseptic techniques and had them re-review the lab's standard operating procedures for sterile procedures.

The IACUC believes its investigation of this incident was thorough and the corrective actions appropriate to prevent a similar occurrence. If you have questions regarding this incident, please contact me or Dr. David Martin, Director, IACUC Office.
