The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your November 21, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Emory University, following up on an initial report on July 23, 2019. According to the information provided, OLAW understands that several mouse pups were inappropriately euthanized using a microisolator lid. Several mice were found to be still alive in a carcass bag.

The immediate action taken upon discovery consisted of appropriately euthanizing the pups. The corrective actions consisted of retraining the responsible laboratory member on euthanasia techniques, having the Principal Investigator review the content of all protocols with the laboratory staff, and noting the incident in the laboratory member's personnel file.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to correct and prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

The Emory University Institutional Animal Care and Use Committee (IACUC), through the Institutional Official, is reporting the results of an event as required by section IV, F, 3a of the *Public Health Service Policy on Humane Care and Use of Laboratory Animals* (PHS Policy). A preliminary report was provided via email to your office on July 23, 2019. This is the final report regarding improper euthanasia of mice. The associated NIH-funded grant is IK08HL136873-01.

Situation and Assessment

On July 18, 2019 an incident occurred where a lab member incorrectly euthanized a cage of mice pups with a microisolator lid. Some of the mice pups were found later moving around in a carcass bag. The pups were then appropriately euthanized.

The corrective actions to prevent recurrences are detailed as follows:

- The lab member has retaken EU DAR euthanasia training.
- The PI re-reviewed all protocols with the lab personnel.
- 3. This incident has been documented in the personnel's HR file.

The IACUC believes its investigation of this incident was thorough and the corrective actions appropriate to prevent a similar occurrence. If you have questions regarding this incident, please contact me or Dr. David Martin, Director, IACUC Office.
