\*\*\*The IACUC has not updated their reports to the Institutional Official (IO) at least once every six months as required. The last Semi-annual IACUC Report submitted to the IO was dated 1/31/17 and pertained to the IACUC's December 2016 semi-annual reviews of the program for animal care and animal facility inspection. Although the IACUC did conduct semi-annual reviews in Spring 2017, almost 8 1/2 months have elapsed since the IACUC prepared and updated their semi-annual report to the IO.

Per this Section of the Regulations, reports of the IACUC semi-annual evaluations of the program for animal care and animal facility inspection should be updated at least once every 6 months upon completion of the required semiannual evaluations and the report should be submitted to the Institutional Official.


