Dear Dr. Mohapatra,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 1, 2019 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of California Davis, following up on an initial telephone report on January 8, 2019. According to the information provided, OLAW understands that surgery was performed on a nonhuman primate which had lost more than 15% body weight, which was contrary to what had been approved in the protocol. The animal had been carefully monitored by numerous subject matter experts and was determined to be healthy but the conduct of the surgery on an animal with this percentage of weight loss constituted a protocol deviation.

The corrective actions consisted of implementing use of a mathematical algorithm to calculate body weight loss and to send this information to personnel involved. Veterinary staff will be consulted prior to the conduct of any proposed surgeries.

Based on its assessment of this explanation, OLAW understands that measures have been implemented to prevent recurrence of this problem. OLAW concurs with the actions taken by the institution to comply with the PHS Policy.

Follow-up to protocol deviation report for R01 MH107333

Dear Dr. Wolf:

In accordance with Assurance D16-00521 # (A3433-01) and PHS Policy IV.F.3., UC Davis is bringing to your attention a protocol deviation and the corrective action taken to mitigate future such occurrences. This situation was previously reported over the phone by our IACUC Director, Donna Routley.

A single animal weight loss exemption was approved by the IACUC, which specified that surgical procedures would only occur when the individual NHP animal's weight loss did not exceed 15%. For one animal, this exemption was not followed and the approved surgery was performed. Although the animal had been monitored closely by the CNPRC SRA's, AHT, researchers, primate medicine, and the veterinarians for weight loss and overall health and appetite, as a group they did not establish a clear decision tree for the one person responsible for evaluating the percentage of weight loss to determine if procedures could be performed. While this represents a protocol deviation, we note that prior to the surgery the animal underwent a physical and had a body condition score of 2.5. From a health perspective the animal was deemed suitable for surgery.

It is UC Davis' expectation that the Principal Investigator is responsible for ensuring procedures described in animal care and use protocols and any approved amendments or exemptions to IACUC policy are adhered to. The IACUC was satisfied with the proposed plan moving forward to use a mathematical algorithm "Project Weight Loss" to calculate and automatically email to stakeholders

the percentage of body weight loss for individual project animals. Additionally, moving forward, the veterinary staff will be consulted about 1-2 weeks prior to any surgical procedures that is scheduled to occur under this protocol.
